DEFENSIVE DRIVING (DDC-8/6) INSTRUCTOR DEVELOPMENT COURSE INSTRUCTOR REQUIREMENTS

1. Possess current certification in the National Safety Council's Defensive Driving 6-Hour or 8-Hour Course (DDC-6 is provided in the Instructor Development Course.)
2. Successfully complete the National Safety Council's Defensive Driving 8/6-Hour Instructor Development Course (3-day course).
3. Be monitored by a DDC-8/6 Instructor-Trainer for at least 2 probationary classes.
 - a. Monitoring fee and travel extra.
4. Maintain Annual Agreement (contract).
 - a. Private Sub-Agency Agreement authorizes training of company employees only, at any company location, worldwide. Public Sub-Agency Agreement authorizes training of anyone within set territory (i.e. 2-3 parishes in Louisiana). Agreements must be approved prior to Instructor Development Course. If outside South Louisiana, contact local Chapter or nearest NSC Office contract details.
5. Optional for Private Sub-Agencies only: Maintain National Safety Council membership to take advantage for member discounts. Membership is required for Public Sub-Agencies.
 - a. Annual dues are based on the average number of full-time employees and begin at \$395*. Membership information available upon request or visit www.metrosafety.org. Dues may be tax deductible.
6. Each instructor must teach a minimum of two DDC-8/6 courses per year.
7. Purchase/lease all required NSC training materials from local Chapter or NSC Office:
 - a. Teaching Kit includes 12-month video lease (\$750.00*). Includes DVD videos and PowerPoint slides. Annual renewal of lease (\$450*).
 - b. Student Course Guide with Completion Certificate (\$3.80*). Minimum first order for Public Sub-Agency 100. Quantity discounts available.
8. NSC annual instructor renewal fee. (\$65* per instructor.) Includes updated certification card and 12-month subscriptions to *Traffic Safety*, *Driver Trainer* and *Safety+Health*, and the current year's *Injury Facts* CD.
9. Agree to return original films to Chapter or NSC Office upon termination of Agreement or agree to pay fee for lost films. (\$800*)
