NSC FIRST AID & CPR (Standard or Pediatric) INSTRUCTOR REQUIREMENTS

1. Complete the First Aid Training Center and Instructor Agreement.
 - a. If teaching your company employees or the public, complete the First Aid Training Center Agreement (one per company required). FATC Agreement is not required for individuals teaching independently under their own name.
 - b. Each instructor must complete a First Aid Instructor Agreement. If teaching for a FATC, the form must also be signed by a company representative.
2. Attend an Instructor Development Course or be “Grandfathered in” as an instructor.
 - a. Attend 3-day National Safety Council’s First Aid, CPR & AED (Standard or Pediatric) Instructor Development Course. (See reverse for dates, times, cost.)
 - i. Be monitored for 2 probationary classes.
 - b. If you possess current First Aid, CPR & AED teaching credentials, you may qualify to be “grandfathered in” as an instructor without attending an Instructor Development Course. (Call your local Chapter for details.)
3. Purchase all required NSC training materials from local Chapter, including:
 - a. Instructor Resource Kit, which contains instructor manual, teaching videos on USB, student workbook. One kit is included in cost of Instructor Development Course.
 - i. First Aid, CPR & AED #79138-0000 English or #79146-0000 Spanish (\$164.95*)
or
 - ii. Pediatric First Aid, CPR & AED #79158-0000 (\$164.95*)
 - b. Student Manual. (One must be issued to each student for each class.) Includes certificate(s).
 - i. First Aid, CPR & AED #79139-0025 English or #79147-0025 Spanish (\$14.45*)
or
 - ii. Pediatric Plus First Aid, CPR & AED Plus (for LA daycares) #79170-0025 (\$13.95*)
4. Pay NSC instructor renewal fee (\$80/2-year), which is waived for the first year.

NOTE: Manikins, AED trainer, bandages, EpiPen trainer are also available See catalog for details. Also, ask about the NSC Bloodborne & Airborne Pathogens Train-the-Trainer.
